## **MEMBER REPORTS**:

# Center of Excellence, Mary Drexler and Heather Eshleman

June 14th Annual Conference. Still finalizing speakers/panels. The 2022 prevalence study is available online.

Center of Excellence's grantees spoke about their programs:

1. Erik Sullivan:

Mentioned that he developed/helped develop the Prosper app.

Mentioned he would like to work with people in the state and improve the Prosper app.

2. Shannon Dadurka:

Mentioned they are working on data collection and community outreach. They said they need more data.

Darryl Barnes:

Says it is important to have responsible gambling conversations with the General Assembly.

Mentioned the deficit and that there could be 1% funding for Problem Gambling built into iGaming.

Said we need more data in general.

Said people should reach out to Washington Commanders.

Said each Delegate/Senator has monthly newsletters and that could help RG messaging outreach.

Said to reach out to him if anyone would like to present in front of the Black Caucus. Asked if casinos can track patron activity then send patrons RG messaging based on their activities.

## Maryland Coalition of Families, Nicole Ukoumunnee

Asked that when people hear about Problem Gambling education, that they please support education efforts.

## Hollywood Casino, Jasmine Countess on behalf of Jennifer Boyer

Besides English, the casino has responsible gambling messaging in Korean, Vietnamese, and simplified Chinese.

## Ocean Downs Casino, Brenda McNelis

They have a new General Manager, Bobbi Jones. They have bathroom signage, podium signage, and peer cards at podium. Larger font on billboards too.



# Live! Casino & Hotel, Charlie Dwaileebe

RG Cards in smoking area, messaging on screens, larger RG messaging fonts, and more RG training.

## Rocky Gap Casino, Sean Cantner

Peer Counseling Cards at podiums and cages.RG stickers added to every Video Lottery Terminal ("VLT").3-step verification for all additions and removals to exclusion programs.

### Horseshoe Casino, Shamia Holmes

3 trainings per year for RG. Up from 2 trainings per year.

### MGM National Harbor, Kia Johnson and Patrick Martin

Mentioned anti-human trafficking efforts. Around a 2% utilization rate on uptake of RG pamphlets. Has outdoor signage and annual RG refreshers in addition to other materials.
